

Brief summary of receipt of foreign contribution

The details of foreign contribution for the year 2002-03 are as below: -

- (i) The receipt of foreign contribution during 2002-03 amounted to **Rs.5046.51** crores.
- (ii) Among the States and Union Territories, **Delhi** reported the largest amount of foreign contribution (Rs 880.77 crores) followed by **Tamil Nadu** (Rs.774.99 crores) and **Andhra Pradesh** (Rs 629.76 crores).
- (iii) The **United States of America** (Rs1679.84 crores) heads the list of donor countries, followed by **Germany** (Rs 715.04 crores) and **United Kingdom** (Rs 685.38 crores).
- (iv) The leading donor agencies were **Ford Foundation, USA** (Rs.121.94 crores), **World Vision International, USA** (Rs.90.24 crores) and **Foundation Vincent E Ferrer, Spain** (Rs 79.16 crores).
- (v) The largest recipient of foreign contribution was **World Vision of India, Tamil Nadu** (Rs.98.01 crores) followed by **Rural Development Trust, Andhra Pradesh** (Rs.84.66 crores), and **Sri Sathya Sai Central Trust, Andhra Pradesh** (Rs.60.19 crores).
- (vi) Among the purposes, the largest amount was received for **Establishment Expenses** (Rs.673.77 crores) followed by **Rural Development** (Rs 486.50crores), and **Construction and Maintenance of School/College** (Rs.275.74 crores).
- (vii) The top recipient district was **Chennai** (Rs. 363.45 crores) followed by **Bangalore** (Rs.357.66 crores), and **Mumbai** (Rs.283.59 crores)
