The following posts will be filled up on deputation as per details/ eligibility conditions given below :-

1. 1(One) post of Deputy Director (Indoor) in the revised Pay Band + Grade Pay (PB-3) Rs. 15600-39100+6600 on deputation.

Officers of the Central/State Govts./Union Territories/Recognized Research Institutions/Universities/Public Sector Undertakings/Semi Govt./ Statutory or Autonomous Organizations having following qualifications/experience may apply.

- (a)(i) Holding analogous posts on regular basis in the parent cadre/department ; OR
(ii) With 5 year's regular service in the grade rendered after appointment thereto on regular basis in posts in the scale of pay Rs. 8000-13,500(Pre-revised) Revised (PB-2) 9300-34800 + 5400 (GP) or equivalent in the parent cadre /department; and
(b) Possessing the following educational qualifications and experience :
- A. (i) Bachelor's Degree in Law of a recognized university or equivalent.
(ii) Five years' practical experience at the Bar or five years' experience in teaching Law in Training Institute/Recognized Law College.

OR

- B.(i) Master's Degree in Law from a recognized university or equivalent.
(ii) Five years' practical experience at the Bar or three years' experience in teaching Law in Training Institute/Recognized Law College.

The Departmental Assistant Director (Law) with five years' regular service in the grade shall also be considered along with outsiders and in case he is selected for appointment to the post the same shall be deemed to have been filled by promotion.

Note : Where juniors who have completed their qualifying/eligibility service are being considered for promotion, their seniors would also be considered provided they are short of the requisite qualifying/eligibility service by more than half of such qualifying/eligibility service or two years whichever is less, and have successfully completed their probation period of promotion to the next higher grade alongwith their juniors who have completed such qualifying/eligibility service.

Job description of the duties attached to the post

“ To assist in planning & execution of indoor content of various courses run in the Academy. To supervise and conduct all indoor training activity of the Academy and to carryout other duties related to training assigned to him by the Director from time to time”.

(The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion. Period of deputation/contract including period of deputation/contract in another ex-cadre post held immediately preceding this appointment in the same or other organization/department of the Central Government shall ordinarily not exceed 3 years. The maximum age limit for appointment by deputation (including short term contract) shall be not exceed 56 years, as on the closing date of receipt of applications).

2. 3(three) posts of Deputy Assistant Director (Police Science) in the revised Pay Band + Grade Pay (PB 2) Rs. 9300-34800 + Rs. 4200 on deputation (including short-term contract) /Absorption

Officers under the Central/State Govts./Union Territories/Recognized Research Institutions/Universities/Public Sector Undertaking/Semi-Govt./Autonomous or Statutory Organizations :

- (a) (i) Holding analogous posts on regular basis in the parent cadre/ department; Or
- (i) With three years' service in the grade rendered after appointment thereto on regular basis in posts in the scale of Rs. 5500-9000(Pre-revised) Revised (PB 2) Rs. 9300-34800 + Rs. 4200(GP) or equivalent in the parent cadre/department; OR
- (ii) With six years' service in the grade rendered after appointment thereto on regular basis in posts in the scale Rs. 5000-8000(Pre-revised) Revised (PB 2) Rs. 9300-34800 + Rs. 4200(GP) or equivalent in the parent cadre/department; and
- (b) Possessing the educational qualifications and experience :
- (i) Bechelore's Degree in Law or Master's Degree in criminology from a recognized university or equivalent.
- (ii) Two year's practical experience at the Bar or two year's teaching experience in the Police Training Institutes.

Job description of the duties attached to the post

“Officer to teach IPC, Cr.PC, Evidence Act, Minor Act and other Allied Subjects, on Police Science and Crime Investigation etc. to the DySPs and Sub-Inspectors of basic trainees,

including various short term courses. Also to carryout other duties related to training assigned to him by the Director from time to time”.

(Period of deputation/contract including period of deputation/contract in another ex-cadre post held immediately preceding this appointment in the same or other organization /department of the Central Government shall ordinarily not exceed 3 years. The maximum age limit for appointment by deputation(including short term contract) shall be not exceed 56 years, as on the closing date of receipt of applications).

Selection personnel will have the option to draw their basic pay in the scale of pay of their parent department plus following admissible during the period of deputation.

- i) Trg. Allowance (inclusive Deputation Duty Allowance) @ 30% on basic pay +G.P. for Dy. Director (Indoor) and @ 15% for Dy. Asstt. Director (Police Science).
- ii) SDA @ 12.5% on Basic Pay +G.P. for those having all India Transfer Liabilities.
- iii) Transport Allowance as per slab & other facilities like Rent free accommodation, Medical, Education, Welfare etc.

Application along with bio-data should reach the undersigned within 60 days from the date of circular along with last 5 years confidential reports for the above mentioned posts(i.e. the posts of Dy. Director(Indoor) and Dy. Asstt. Director (Police Science). While forwarding applications it may kindly be confirmed whether there is any vigilance case and disciplinary proceedings either pending or contemplated against any of the applicants. Applications which are not accompanied by the relevant particulars or otherwise incomplete or received after the last is over, will not be entertained. The candidates who apply for the post will not be allowed to withdraw their candidature subsequently.
